### **VII. Educator Preparation Updates (Tracey)**

#### **A. Preservice Teacher Permit**

Beginning July 1, 2024, any student placed in an education field setting must hold an Ohio Pre-Service Teacher Permit. See ORC Section 3319.0812 as part of HB 33 effective October 3, 2023.

-The law states that the permit will be valid for 3 years. The State Board recently added a one year option as well.

- Our students will apply for this permit using the same OH|ID Core System educators use to apply for their teaching license.

- If you read the code, you will see that the permit allows districts to employ these students as substitute teachers, in lieu of having them apply for a separate substitute teaching license.

- SBoE will only require background checks at the time of applying for the permit. All students with this permit will be automatically enrolled in the Rapback system. We will receive notice if there is any arrest or conviction and will promptly notify you.

#### **B. Science of Reading Related- ORC 3333.048 Educator Preparation; Metrics and programs.**

- **Science of Reading Audit Metrics** have been determined to perform the eventual audits for Ohio's teacher preparation programs that will begin in early 2025.
- The metrics align with the International Dyslexia Association's Knowledge and Practice Standards (KPS) for Teachers of Reading (2018), the Ohio Department of Higher Education (ODHE) Reading Standards (2023), and best practices for teacher prep programs as identified by experts in the field.
- This Course Alignment and Planning Tool will be used to determine each individual institution's 12-hour reading and literacy course alignment to the Science of Reading. The auditors will complete the Course Alignment and Planning Tool by collecting data through course observations, faculty and student interviews, syllabi reviews, and textbook reviews at each institution.

## **2. Field Placement**

(4) Ensure that clinical preparation for all educators who are responsible for teaching reading only occur in the classrooms where the local education agency has verified that the practicing teachers have training in literacy instruction strategies aligned to the science of reading, use instructional materials aligned to the science of reading from the list established under section 3313.6028 of the Revised Code, and actively implement a structured literacy approach.

## **3. WSU response to these**

- Redesigning our 12 hour reading core and 3 hour reading in the content class to align with 2023 standards
- Required all EED students to take the 18 hour Dyslexia Modules in 2023/24. Will add the science of reading modules in 2024/25
- Requested trained cooperating teachers for fall 2025 placements involving reading at the P-5 level or intervention settings- have a grant to give districts \$150.00 per CT involved in these placements that can be given as an extra CT stipend or used for science of reading materials.

### **C. Licensure Grade Bands**

- HB 33- Budget Bill- contained language to change grade bands to PK-8 and 6-12. ODHE has not formed any committees to address these changes yet. They have shared that they will develop the teacher candidate assessments for these before they develop the standards. We have no guidance as of now and are continuing with the current programs, while discussing what a PK-8 program would look like.
- SB 219- seeking to return to our current grade bands.
