To gain admission, candidates must have: 1) a bachelor's degree, 2) a current teaching license, 3) a GPA of 2.7 or higher for all undergraduate coursework, 4) a GPA of 3.0 or higher for all previous graduate coursework (if applicable), 5) GRE or MAT scores in the 50th percentile or higher or undergraduate GPA of 3.0 or higher or a previously earned master's degree, and 6) at least 2 yrs classroom teaching experience. Candidates must submit an application and a copy of their teaching license.

Pre-Service Teacher Survey Results

Description of Data:

To gather information on student satisfaction with the quality of preparation provided by their educator preparation programs, the Ohio Department of Higher Education administers a survey aligned with the Ohio Standards for the Teaching Profession (OSTP), Ohio licensure requirements, and elements of national accreditation. All Ohio candidates receive an invitation to complete the survey during their professional internship (student teaching). The results of this survey are reflected here. A total of 3,342 respondents completed the survey statewide for a response rate of 69 percent.

Purpose:	To afford K-3 students and teachers, local communities, and universities a living laboratory for learning and innovation
Goal:	To provide access to science, technology, engineering, and math (STEM) teaching for Early Childhood teacher candidates
Number of Participants:	98
Strategy:	The early childhood science methods course is taught on site at four different public elementary schools within a five-mile radius that are diverse culturally, economically, and in the unique needs of the learners. Using school gardens as outdoor classrooms, candidates are solely responsible for science instruction for approximately half of each class time. In two of the school sites, the teacher candidates work in small groups with the K-3 students and in others, they co-teach the whole class with the classroom teacher. In each setting, candidates plan inquiry-based STEM lessons to investigate ways to understand and address social, cultural, and ecological health issues relevant to the school community. Candidates apply the national and state standards and practices as they teach the STEM content in the outdoor classroom. In all of the schools, families of the K-3 students are invited to participate in at least one learning experience in the garden. The overall experience of the garden as an outdoor classroom provides both teacher candidates and classroom teachers in-depth hands-on experience to practice and enhance STEM teaching in grades K-3.
Demonstration of Impact:	A research project using case study methodology was conducted on 3 cohorts of teacher candidates (N=72). Data was collected from classroom observations in the schools, teacher candidates' written reflections, and individual interviews. Illustrative themes show that teacher candidates: 1) identified themselves as teachers of STEM; 2) evolved from a teacher-centered view of teaching to a more student-centered view where they know how to engage their P-3 students as co-constructors in learning experiences; 3) improved their listening and reflection of the dialogue with and between the children; and 4) developed a "lived" understanding of the varying cultural, ecological, sociological, and individual issues and needs impacting K-3 students.

Purpose:	To create nurturing and academically responsive programming for ESL students while simultaneously offering teacher candidates dynamic faculty co-teaching experiences
Goal:	To provide ongoing support for both ESL students in DPS and teacher candidates preparing for Culturally and Linguistically Diverse classrooms.
Number of Participants:	400
Strategy:	This program is based upon the concept of continual renewal. The program began with the modest goal of pairing every ESL student with a tutor or mentor. Through that initial project, we assessed needs through triangulated methods of data collection that included: Candidate projects, student success rates socially, emotionally, culturally, linguistically, and academically (observed and tracked through Ohio Graduation Test [OGT] and Ohio Test of English Language Acquisition [OTELA] scores and student grades), teacher feedback and classroom collaborations, and administrative needs. We also evaluated new problems that emerged and continue to emerge yearly. We then build from the current foundation to address these needs.
Demonstration of Impact:	Since 2011, the partnership has grown in response to the simultaneous needs of the district and university. Currently, the program has several school-based initiatives, serves over 200 CLD students,

Strategy: A collaborative partnership was actualized between WSU Middle Childhood Education Program and Fairborn Intermediate for Fall Semester, 2016. WSU MCE candidates in ED 4080, ED 4210, and ED 6360 were involved in working with 4th and 5th grade students at Fairborn Intermediate. Candidates provided data-supported individualized hands-on activities to meet the needs of Fairborn students; activities centered around phonics and word study, literature discussion and chapter books, and hands-on science lessons. Fairborn students were provided individualized instruction based on their learning needs through this collaborative.

Demonstration of Impact: Survey data shows that 100% of WSU candidates enjoyed working with the Fairborn students and Fairborn students reciprocated by identifying that 98% enjoyed working with WSU MCE candidates in return. After this semester-long collaborative experience, 91% of WSU MCE candidates reported that working with the Fairborn students had increased their interest in becoming an educator. Having the opportunity to work with college students, the Fairborn students' interest in attending college someday was reported 89.7% agreement.
